Graduation from high school (HS) or GED completion.	Applicant requests official high school transcript from HS Counseling Office or requests GED from www.ged.com . Send directly to VHCC Admissions Office. It is the student's responsibility to verify with the Admissions Office that transcripts have been received.	
All official College/University Transcripts (excluding VCCS – Virginia Community Colleges)	Applicant requests colleges/universities to send official transcripts to VHCC Admissions Office.	
One unit Biology with Lab ("C" or better grade)	HS Biology or college Biology (BIO 101 at VHCC or equivalent transfer)	
One unit Chemistry with Lab ("C" or better grade)	HS Chemistry or college Chemistry (CHM 5 or CHM 111 at VHCC or equivalent transfer)	
Students must be eligible for ENG 111.	Via VPT scores or SAT/ACT/GED scores or have completed ENG 111 (grade "C" or better) or VCCS Direct Enrollment policy.	
Students must be eligible for MTH 154.	Via VPT scores or SAT/ACT/GED scores or have completed MTH 154 or higher or VCCS Direct Enrollment policy.	
A cumulative GPA of 2.0	Applicants must be high school graduates, or equivalent, and must reflect "C" average. A cumulative GPA of 2.0 must be achieved on all college work.	
Shadowing/Observation - Applicant must also complete twelve (12) hours of observation in a Hospital Radiology Department (NOT a clinic, urgent care, outpatient center, or doctor's office). Observation must be documented by radiology personnel denoting date(s) and time(s).	Contact a HOSPITAL Radiology Department Manager to schedule. Please begin this process early as the hospitals have orientation and shot record requirements before you can begin observation hours. Contact your hospital of choice for details.
